ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF INLET MARINA VILLAS CONDOMINIUM ASSOCIATION, INC.

Pursuant to the provisions of \$617.1006, Fla. Stat., INLET MARINA VIDAS CONDOMINIUM ASSOCIATION, INC. ("Association") adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: Amendment adopted:

Article VII, Section 1 of the ARTICLES OF INCORPORATION OF INLET MARINA VILLAS CONDOMINIUM ASSOCIATION, INC. ("Articles of Incorporation"), attached as Exhibit "F" to that certain Declaration of Condominium of Inlet Marina Villas Condominiums, recorded in Official Records Book 3727, Page 0266, et. seq., of the Public Records of Volusia, Florida, as may have been amended from time to time, is hereby amended as follows (additions are indicated by underlining; deletions are indicated by strike-outs, omitted and unaltered provisions are indicated by ellipses):

[...]

ARTICLE VII Management

Section 1. The affairs of the Association shall be managed and governed by a Board of Directors composed of <u>five (5) Directors</u>-not less than-three (3) nor-more than the number specified-in-the-Bylaws. The Directors, subsequent to the first Board of Directors, shall be elected at the annual meeting of the membership, for <u>such a terms as specified in the Bylaws of one (1) year</u>, or until their successors-shall be elected and shall-qualify. Provisions for such election, and provisions respecting the removal, disqualification and resignation of Directors, and for filling vacancies on the Directorate, shall be established by the Bylaws consistent with the provisions of the Declaration of Condominium.

SECOND: The date of adoption of the Amendment by the membership was the 15th day of July, 2024.

THIRD: Adoption of Amendment:

Article XI of the Articles of Incorporation provides that amendments to the Articles of Incorporation shall be approved upon the affirmative vote of not less than a majority of those voting members of the Association who are present in person or by proxy and voting at a Meeting at which a quorum has been established.

The Members of the Association were entitled to vote on the Amendment. The Members of the Association duly adopted this Amendment in accordance with the above-stated provision. The number of votes cast for the Amendment was sufficient for approval.
