AMENDMENT TO THE ARTICLES OF INCORPORATION OF OAKS EAST HOMEOWNERS ASSOCIATION, INC.

<u>ITEM 1</u>: Article VIII(1) of the Articles of Incorporation shall be amended to read as follows:

Directors. The affairs of the Association will be managed by a Board consisting of not less than three (3) five (5) nor more than five (5) seven (7) Directors. The number of Directors on the Board until the Transfer Date shall be three (3). Thereafter, the number of Directors shall be five (5). . .

ITEM 2: Article VIII(1) of the Articles of Incorporation shall be amended to read as follows:

After the Developer elects to divest itself of control of the Association, Directors must be members of the Association, or the spouse of a member.
