ARTICLES OF DISSOLUTION
of
THE JIMMY FOUNDATION, INC.

Pursuant to Section 617.1403 of the Florida Statutes, the undersigned director of **THE JIMMY FOUNDATION, INC.**, a Florida not-for-profit corporation (the "Corporation"), submits the following Articles of Dissolution for the purpose of dissolving the Corporation:

1. The name of the Corporation as currently filed with the Florida Department of State is **THE JIMMY FOUNDATION, INC.**
2. The document number of the Corporation is N38320.
3. The Corporation has no members or members entitled to vote on the dissolution. The dissolution of the Corporation was authorized by unanimous consent of the directors of the Corporation on February 7, 2018.
4. The effective date of dissolution of the Corporation is February 7, 2018.
5. All debts, obligations, and liabilities of the Corporation have been paid or discharged.
6.
