I have received a Notice of Administrative Dissolution or Revocation of the above-referenced corporation, apparently as a result of failure to file its corporation annual report for the year 2001.

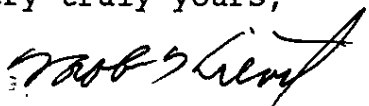
