Pursuant to Section 617.1006, Florida Statutes, the following provisions of the Articles of Amendment to Articles of Incorporation of HIDDEN VILLAGE HOMEOWNERS ASSOCIATION OF OCALA, INC., a Florida non-profit corporation, filed in Tallahassee on November 1, 1990, be and they are hereby amended in the following particulars:

I.

Article VIII, Board of Directors, is hereby amended to read as follows:

The business and affairs of the corporation shall be conducted, managed and controlled by a Board of Directors. The Board shall consist of not less than three (3), nor more than seven (7) members. The Board may delegate such operating authority to such companies, individuals or committee as it, in its discretion, may determine.

II.

The date of the adoption of each amendment is the date this Amendment to Articles of Amendment are filed with the Florida Department of State.

III.

The amendment was adopted by the members and the number of votes cast for the amendment was sufficient for approval.
