Dear Andy,

As per our telephone conversation today, I am sending in our corporation reinstatement form and fees for the years 2001, 2002, and 2003. As I stated in our conversation, our treasurer submitted the Annual Uniform Report with our check in 2001 as requested. We never received a cancelled check back from that mailing, nor did we receive notice of receipt or non-receipt of our submission. Since the document and check did not apparently reach your office, we were subsequently dissolved in 2001. I took over the presidency of the group in September of 2002, and have only recently been made aware of our incorporation status, which we wish to reinstate.

With this letter and payment, and according to your instructions, we are enclosing a check (my personal check) in the amount of \$183.75 plus an additional \$8.75 for a copy of our certificate, to bring us up-to-date for the past three years.
