FIRST: Amendment(s) adopted:

II Duration

The period of its duration is perpetual. However, if the association is dissolved, the property consisting of the surface water management system will be conveyed to an appropriate agency of local government. If this is not accepted, then the surface water management system will be dedicated to a similar non-profit corporation.

III Purpose

This association is organized for the purpose of providing an entity for the operation of a industrial park located in Lee County, Florida, and known as Cape Coral-Lee County Industrial Park, ("the Park") operated under the declaration of covenants, conditions and restrictions ("the declaration"). The Association shall have all of the common-law and statutory powers of a not-for-profit corporation under the laws of Florida that are not in conflict with the provisions of these Articles, the Declaration, the Bylaws, or the Act.

This association has the power to:

- a. own and convey property;
- b. operate and maintain common property, specifically the surface water management (SWM) as permitted by the SFWMD including all lakes, retention areas, culverts and related appurtenances;

- c. establish rules and regulations;
- d. assess members and enforce assessments;
- e. to sue and be sued;

and

f. contract for services to provide for operation and maintenance services.
