#### ARTICLES OF INCORPORATION

OF

#### LEE COUNTY FIRE MARSHAL'S ASSOCIATION. INC.

We the undersigned incorporators, hereby associate ourselves together and make, subscribe, and acknowlege these Articles of Incorporation for the purpose of forming a corporation, not for profit. In accordance with the laws of the State of Florida.

#### ARTICLE I

The name of this corporation shall be Lee County Fire Marshal's Association. Inc. and its principal office is located at Iona Mcgregor Fire District, 16551 McGregor Blvd., Fort Myers, Florida (Lee County). The Board of Directors may from time to time designate such other post office address and place for the principal office of this corporation as it may seem fit. The registered agent of the Lee County Fire Marshal's Association. Inc. shall be Julius Barab, 2055 Central Ave., Fort Myers. Florida 33908 (Lee County).

#### ARTICLE II

The corporation shall have perpetual existance.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### ARTICLE III

The general nature, objectives, and purposed to be transacted by this corporation shall be: to unite for fire prevention thru inspection, code enforcement, public education, and/or arson suppression; to serve as a central county agency for gathering and exchange of technical information in the field of fire prevention; to unify the efforts of the fire prevention officials and all persons concerned with fire prevention, throughout Lee County in the enforcement, strengthening and upgrading of all codes and standards used in Lee County, the State of Florida, and the Fire Protection Districts; to serve as the voice of proffesional fire prevention officials in Lee County; and to actively promote the highest standard of professionalism and conduct among fire prevention officials throughout Lee County.

#### APTICLE IV

The members of this corporation shall consist of three classes: ACTIVE, ASSOCIATE, and HOHORAPY.
