AMENDMENT TO ARTICLES OF INCORPORATION OF WEST BROWARD COMMUNITY CHURCH, INC.

- 1. The name of the corporation is: WEST BROWARD COMMUNITY CHURCH, INC.
- 2. The corporation is desirous of amending its Articles of Incorporation as follows:

ARTICLE III

MEMBERSHIP
