ARTICLES OF DISSOLUTION

OF

Pursuant to §617.1403, Florida Statutes, this corporation submits the following Articles of Dissolution:

FIRST: The name of the corporation is LELA AND JESSE KING SCHOLARSHIP FOUNDATION, INC.

SECOND: No membership meeting for the Articles of Dissolution was necessary. However, the three members of the Board of Directors constitute all of the members of the corporation. A Resolution to dissolve the corporation, with the effective date of dissolution being December 1, 1999, was adopted by the unanimous vote and written consent of attachment members of the Board of Directors of the corporation, and executed in accordance with Florida Statute §617.071.

THIRD: The plan of distribution of assets, a copy of which is attached hereto and incorporated herein, was also adopted by the unanimous vote of all members of the Board of Directors and by the written consent of the three members of the Board of Directors of the corporation, and executed in accordance with Florida Statute §617.071.

- 3. There are no assets received and held by the corporation subject to limitations permitting their use only for charitable, religious, eleemosynary benevalent educational, or similar purposes, but not held upon a condition requiring return, transfer or conveyance by reason of the dissolution.
- 4. Distribution of any remaining assets of the corporation will be made, in accordance with Article IX of the Articles of Incorporation, to Lees-McRae College, Banner Elk, North Carolina.
