

CHARTER OF OKALOOSA COUNTY FAIR ASSOCIATION, INC.

THE HONORABLE JUDGE OF THE CIRCUIT COURT OF THE FIRST JUDICIAL

CIRCUIT OF FLORIDA, IN AND FOR OKALOOSA COUNTY, PLORIDA;

WE, THE UNDERSIGNED, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida applicable to public fairs and expositions, as set forth in Chapter 616 of the Florida Statutes.

ARTICLE I - NAME

The name of this corporation shall be OKALOOSA COUNTY FAIR ASSOCIATION, INC., and its principal offices shall be located in Fort Walton Beach, Okaloosa County, Florida.

ARTICLE II - OBJECT

The general nature and object of the corporation shall be to conduct and operate a public fair and exposition for the benefit and development of the agricultural, horticultural, livestock, or other resources of Okaloosa County, Florida, and shall promote and carry on such activities for the sole purpose of the benefit and development of such educational, agricultural, horticultural, livestock, and other resources of the State of Florida in the above-mentioned County and State.

ARTICLE III - MEMBERSHIP

The corporation shall consist of not less than twenty-five (25) members, and shall consist initially of the twenty-five (25) individuals whose names are appended hereto, set forth in Article V of this Charter. Members thereafter shall be admitted and shall constitute all members in good standing of the Fort Walton Beach Shrine Club. Their membership shall continue and be valid as long as they are members in good standing of the Fort Walton Beach Shrine Club.

ARTICLE IV - EXISTENCE

The corporation shall have perpetual existence,

ARTICLE'V - OFFICERS

The affairs of this corporation shall be managed by the Board of Trustees which shall consist of not less than seven (7) members. From such Board of Trustees there shall be elected a President, Vice-President, First Vice-President, Secretary, Treasurer, and Executive Director, to serve for terms of one (1) year each. ARTICLE VII - BY-LAWS

The By-Laws of this Corporation shall be made, altered, or rescinded by the Board of Trustees, subject to approval of the general membership of the annual meetings thereof.

The highest amount of indebtedness or liability to which the corporation may at any time subject itself is Five Hundred Thousand (\$500,000.00) Dollars.

ARTICLE IX - NON-PROFIT STATUS

No part of the net earnings of this corporation shall inure to the benefit of any individual or member.

ARTICLE X - DISTRIBUTION OF ASSETS UPON DISSOLUTION

In the event of dissolution, the residual assets of the organization will be turned over to the one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954, or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State or Local government for exclusive public purposes.
