AMENDMENT TO ARTICLES OF INCORPORATION

PURSUANT to the provisions of Chapter 607, Florida Statutes, the undersigned corporation hereby adopts the following articles of amendment to its Articles of Incorporation:

1. The name of the corporation is presently GINGER PLACE HOMEOWNER'S ASSOCIATION, Inc.

2. At a duly called meeting of the board of directors, at which the officers and all shareholders were present, on February 16, 1997, the following amendment to the Articles of Incorporation was adopted by unanimous vote.

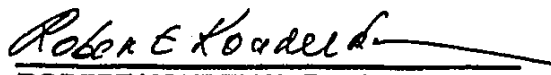
3. The amendment to be adopted is to change the name of the corporate entity from the existing name to NUTMEG COURT HOMEOWNERS ASSOCIATION, INC.

4. There is no reclassification cancellation or exchange of issued shares pursuant to this amendment.

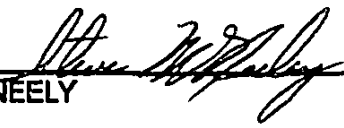
5. The amendment was adopted on February 16, 1997. A vote of the shareholders was unanimous as well as a unanimous vote of the board of directors and the officers of the corporation.
