Round Lake Association, Inc., is a voluntary association of the owners of property on Round Lake, an 11-acre lake in Lutz, Florida. It is responsible for the operation and maintenance of a deep well installed some thirty years ago to maintain the level of the lake.

Round Lake Association, Inc., was declared inactive on 9/21/2001, apparently as a result of non-receipt of the required annual report. The president and registered agent for Round Lake Association at the time, Mr. Roger Schatzel, sold the property and moved away. Apparently the new owner did not know what to do with the annual report notices, and may have thrown them away. In any case, the corporation did not receive the notices. I am, therefore, requesting a waiver of the reinstatement fee for Round Lake Association.
