

CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF RIVER VISTA HOMEOWNERS' ASSOCIATION, INC.

A Corporation Not-For-Profit Under the Laws of the State of Florida

The Articles of Incorporation of River Vista Homeowners' Association, Inc. were filed with the Florida Secretary of State on July 30, 1990. The same Articles of Incorporation were recorded in Official Records of St. Lucie County, Florida at Official Records Book 721, Page 85, et. seq. and amended at OR Book 1212, Page 2645 et. seq. The same Articles of Incorporation are hereby amended as approved by the membership by vote sufficient for approval at a Members Meeting held on March 15, 2005.

1. Article VII is amended to read as follows:

A Section of the second

ARTICLE VIII – BOARD OF DIRECTORS. The affairs of the Association shall be managed by a Board of Directors which shall consist of five (5) members. Members of the Association, spouses of members of the Association, persons qualified under Florida Statutes §617.0802(2)(2004), as amended from time to time, and spouses of persons qualified under that statute are eligible to serve on the Board of Directors. Directors shall be elected at the annual members' meeting, and shall serve for staggered two (2) year terms. The members of the Board shall serve without compensation, but shall be reimbursed for travel or other necessary and approved expenses.

(The balance of Article VIII remains unchanged)

- 2. The foregoing amendment to the Articles of Incorporation of River Vista Homeowners Association, Inc. was adopted by the membership by a vote sufficient for approval at the Annual Members Meeting held on March 15, 2005.
- 3. The adoption of this amendment appears upon the minutes of said meeting and is unrevoked.
- 4. All provisions of the Articles of Incorporation of River Vista Homeowners' Association, Inc. are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
