Dear Mr. secretary,

I am sending you a corporation reinstatement form concerning the "Lakes in Regency Park Civic Association" document number 762955, with a stipulation from the "Church of the Covenant" document number N00000003793, along with an order signed by Circuit Court Judge Bulone of the Sixth Judicial Circuit of Florida.

The "Covenant Foundation" document number N39476, through FRAUD, illegally merged the "Lakes in Regency Park Civic Association" into itself, and then merged itself in to the "Church of the Covenant". Both the "Church of the Covenant", and the "Covenant Foundation" are essentially one in the same.

Zeke Blevins formerly of the "Church of the Covenant", and the "Covenant Foundation", was adjudicated guilty of this fraud and was sentenced to prison. In a deal to reduce his sentence, the "Church of the Covenant" agreed to rescind the fraudulent merger among other things.

Per request from your office, an order from Judge Bulone rescinding the fraudulent merger between the "Covenant Foundation", and the "Lakes in Regency Park Civic Association" and reinstating the "Lakes in Regency Park Civic Association" is included.

STIPULATION TO RESCISSION OF
ALL CONSOLIDATION TRUST AGREEMENTS AND MERGERS

It is hereby stipulated by and between THE CHURCH OF THE COVENANT, INC. and THE COVENANT FOUNDATION, INC. and ESTEL MILLARD BLEVINS and MARY BLEVINS and THE LAKES IN REGENCY PARK CIVIC ASSOCIATION, INC. and THE NEW LAKES IN REGENCY PARK CIVIC ASSOCIATION, that all "consolidation trust agreements" in existence between the COVENANT FOUNDATION, INC and THE LAKES IN REGENCY PARK CIVIC ASSOCIATION, INC. are hereby revoked and rescinded. Further, the above parties hereby revoke and rescind any and all mergers concerning THE COVENANT FOUNDATION, INC. and THE LAKES IN REGENCY PARK CIVIC ASSOCIATION, INC. filed with the State of Florida and/or any other jurisdiction. This stipulation is intended to completely separate THE COVENANT FOUNDATION, INC. and/or its successors or assignees from THE LAKES IN REGENCY PARK CIVIC ASSOCIATION, INC. and its successors and/or assignees. Further, THE COVENANT FOUNDATION, INC and THE CHURCH OF THE COVENANT, INC and/or their successors or assignees will file with the Florida Department of State, Division of Corporations the proper documents rescinding all mergers between THE COVENANT FOUNDATION and THE LAKES IN REGENCY PARK CIVIC ASSOCIATION, INC.

**ORDER RESCINDING CONSOLIDATION TRUST AGREEMENT AND MERGER
AND REINSTATING CORPORATION**

This cause coming on to be heard upon stipulation by the parties, and the Court being fully advised finds as follows:

1. The Defendant by fraud, deception and/or misrepresentation obtained a "consolidation trust agreement" with the "Lakes in Regency Parks Civic Association, Inc." and filed a merger document (Document number 762955) with the State of Florida that merged the "Covenant Foundation, Inc." and the "Lakes in Regency Parks Civic Association, Inc."


2. The Defendant pled ^{no contest} ~~guilty~~ to the offense of scheme to defraud on 3/23/04 and was adjudicated guilty of the Scheme to Defraud.

3. All parties involved including any successor or assignee have stipulated to a rescission of all "consolidation trust agreements" in existence as well as a rescission of the merger filed with the Florida Department of State, Division of Corporations.

4. It is also agreed that the "Lakes in Regency Parks Civic Association, Inc." shall be reinstated by the Court.

IT IS THEREFORE ORDERED AND ADJUDGED that all "Consolidation trust agreements" between the "Covenant Foundation, Inc." and the "Lakes in Regency Park Civic Association, Inc." are hereby rescinded and/or revoked. The merger between the "Covenant Foundation, Inc." and the "Lakes in Regency Park Civic Association, Inc." which was submitted to the Florida Department of State on January 22nd 2003, is hereby rescinded and set aside, and the Florida Department of State, Division of Corporations shall reinstate the corporation known as the "Lakes in Regency Park Civic Association, Inc."
