**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF
SAFE START USA, INC.**

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, **Safe Start USA, Inc.**, a Florida not-for profit corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is Safe Start USA, Inc.
2. The original Articles of Incorporation for the Corporation were filed on August 13, 1990, and assigned Charter No. N39849.
3. By the execution of a unanimous written consent executed on January 31, 2012, the Corporation's board of directors have approved, authorized, and directed that Article 1 of the Corporation's Articles of Incorporation be amended and restated. There are no members entitled to vote on the amendment, and the amendment was adopted by the board of directors.
4. Article 1 of the Articles of Incorporation is hereby amended in its entirety to read as follows:

ARTICLE 1 NAME OF CORPORATION
THE MAILING ADDRESS AND THE PRINCIPAL OFFICE ADDRESS.

The name of the Corporation shall be **ISR CFK Foundation, Inc.** The mailing address and the principal office address of the Corporation shall be 2572 West State Road 426, Suite 200, Oviedo, Florida 32761.
