We received the following report to be filed by September 12, 2001 in error. This was filed and taxes paid on April 6, 2001 as we have the returned check in our files.

The Manors of Nottingham Homeowners Association was transferred from the builder to the homeowners on October 18, 1999. At that time there were new directors voted on to form the new board. When we filed the business report for 2000 we noted the new directors on the right column of the report. Also, the changes of the place of business and the mailing address.
