At a congregational business meeting on September 27, 2000, the following motion was made and passed by a vote of 24 YES, 2 No, and 1 ABSTENSION:


"That the church name be changed to "Christ Community Church of the Christian and Missionary Alliance of Bradenton, Incorporated and a new sign be purchased to advertise the same."
