**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION OF  
INTERNATIONAL VISITOR CORPS OF JACKSONVILLE, INC.**

Pursuant to Section 617.1006, Florida Statutes, this Florida Not for Profit Corporation adopts the following amendments to its Articles of Incorporation:

FIRST: The name of the corporation is INTERNATIONAL VISITOR CORPS OF JACKSONVILLE, INC.

SECOND: Article I of the Articles of Incorporation is amended in its entirety to read as follows:

**"ARTICLE I  
NAME OF CORPORATION**

The name of the corporation is **GLOBALJAX, INC.** (hereinafter called the "Corporation")."

THIRD: The foregoing amendment was adopted by the members on March 3, 2011 and the number of votes cast for the amendment was sufficient for approval.

IN WITNESS WHEREOF, the undersigned has executed this instrument as of this 16 day of March 2011.

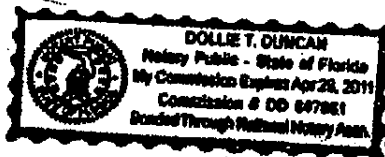
