

### ARTICLES OF AMENDMENT

### KINGS ROAD HOMEOWNERS ASSOCATION, INC

Pursuant to the provisions of Section 607.1020, Florida Statutes, this Corporation adopts the following amendment to it's by laws:

### **FIRST - AMENDMENT ADOPTED**

Article IV - Section 9 Use Restrictions.

Section 9. Every residential structure shall include, at a minimum, a two-car garage. Off-the-road vehicles, jeeps, beach buggies, boats, campers, trailers, motor homes, recreational vehicles, vans, motorcycles, motorbikes, tractors, commercial vehicles of any kind, or any other vehicle, machine, equipment or apparatus (other than operating passenger vehicles) shall not be parked anywhere temporarily or permanently, except in garages, carports, or otherwise enclosed or camouflaged, so as to not be detrimental to the appearance of the property from any Lot line. All vehicles or any thing [lawn mower, wheel barrow, trailer, boat, etc.] cannot be left anywhere visible from any street or neighbor's yard. No parking on the grass for any reason. Any vehicle that is an eye sore not maintained or moved for normal use must be kept in a garage or at an offsite storage site. In this subdivision there is no permanent overnight-street parking allowed, violators are subject to towing and or ticketing.

SECOND - AMENDMENT ADOPTED

Article IV - Section 4 USE RESTRICTIONS.

Section 4. No outside antennas, poles, masts, towers, satellite receiving dishes other than the small three foot or less and then they must be placed in the least compliable place possible to allow line of site or the like shall be erected on any Lot without the prior written authorization of the Architectural Control Board or the Architectural Review Representative, and any such permitted satellite receiving dishes shall be fully concealed and shall not be visible from any Lot Line, if possible. No steel or metal sheds or roofs on any structures, or homes. No roofs are to be covered with solar panels, and if solar panels are requested to be used, they can be if they are not visible from any road-way and they must be approved by the Architectural Control Board.

THIRD - EFFECTIVE DATE

The date of this amendment is effective August 4, 2009.
