Recently, it was brought to our attention that the Corporation was dissolved. At that time, I contacted your office to find out the status and was told no Report was filed in 1998 and a reinstatement form would be mailed. According to our records, the 1998 Annual Report was mailed on March 2, 1998, along with check 2101 for \$61.25. In researching our records, the check is still outstanding. Apparently, it is lost. No report was received for filing in 1999. Since no notice was received from the Division, this was overlooked.
