Enclosed is a completed 2002 Uniform Business Report together with a check in the amount of \$61.25 made payable to the Florida Secretary of State.

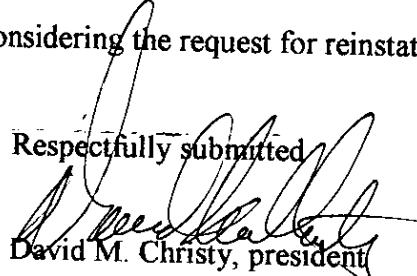
I would respectfully request that the status of the corporation be reinstated and that any additional fees for reinstatement be waived.
