**AMENDMENT**

**(x) ARTICLE IX.**

Said corporation is organized exclusively for charitable, educational, religious or scientific purposes, within the meaning of section 501 (C ) (3) of the Internal Revenue Code (or corresponding section of any future Federal tax code)

**(x) ARTICLE X.**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its member, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of section 501 (c) (3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in

(including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c) (3) of the Internal Revenue Code (or corresponding section of any future Federal tax code)

#### **ARTICLE XI**

( ) Upon dissolution of this Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (C ) (3) of the Internal Revenue Code, I.e. Charitable, education, religious or scientific, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government for a public purpose.

#### **ARTICLE XII**

( ) However, if the named recipient is not then in existence or no longer a qualified distributee, or unwilling or unable to accept the distribution, then the assets of this corporation shall be distributed to a fund, foundation or corporation organized and operated exclusively for the

purposes specified in Sections 501 (C) (3) Of the Internal Revenue Code (Or corresponding section of any future Section of any future Federal Tax Code.)

On October 10, the Board of Directors of Technical Professional Careers Institute, Inc. adopted the amendments to the Articles of Incorporation as set forth by the Internal Revenue Code of Section 501 (c ) (3) for tax-exempt status.

There were no member(s) entitled to vote on the amendment.

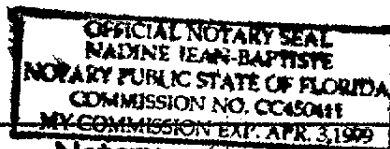
