Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment(s) to its Articles of Incorporation:

Article XII - Dissolution is hereby amended by substituting the following to supercede the present such Article:

## Article XII DISSOLUTION

In the event of the dissolution of the Corporation, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State or local government (or any entity, agency or authority thereof) for exclusive public purpose.

This Amendment is Adopted effective February 23, 2010.

This Corporation has no Members; the Amendment was adopted by the Board of Directors.
