Amendment to Article XI, Paragraph 3 of the Articles of Incorporation as follows:

"Approval of an amendment must be by not less than 75% 66
2/3% of the entire membership of the board of directors
and by not less than 75% 51% of the votes of the entire
membership of the association or by not less than 80% 66
2/3% of the votes of the entire membership of the
association."
