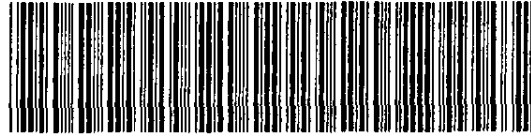

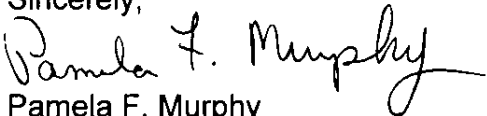

TO  
ARTICLES OF INCORPORATION  
OF  
MT. CARMEL COMMUNITY CHURCH OF JACKSON COUNTY, INC.**

Pursuant to the provisions of F.S. Chapter 617, this corporation adopts the following articles of amendment to its articles of incorporation:
