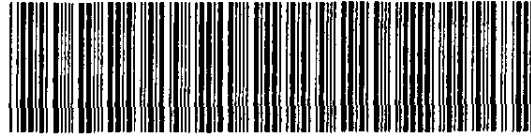



**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
MT. CARMEL COMMUNITY CHURCH OF JACKSON COUNTY, INC.**


Pursuant to the provisions of F.S. Chapter 617, this corporation adopts the following articles of amendment to its articles of incorporation:

- FIRST:** The Articles are hereby amended to reflect that the name of the corporation shall be "ABUNDANT FAITH FULL GOSPEL CHURCH, INC."
- SECOND:** The date of the amendment's adoption was March 5, 2011. The change of name shall be effective at 12:01 AM Eastern Time on the day of filing with the Florida Secretary of State.
