# ADOPTED AMENDMENT TO THE ARTICLES OF INCORPORATION OF SILVER LAKES OF LAKELAND HOMEOWNERS ASSOCIATION, INC.

Item No. 1: Article X of the Articles of Incorporation is hereby amended as follows:

### ARTICLE X. AMENDMENT TO ARTICLES

The Articles of Incorporation may be amended by a vote of the majority of members present in person or by proxy at any special or regular meeting convened for such purpose (in other words, such approval must be by no less than a majority (78) of the membership (154) of the Association). Any amendment to these Articles will be voted upon only after notice of any meeting as required by the By-Laws of the Association.
