I am writing on behalf of the Board of Directors of the 15<sup>th</sup> Avenue Church of Faith in God, Inc. On February 4, 2002 Gary Brown, a person who had been involved in the church, signed an amendment to the Articles of Incorporation renaming the ministry G-Ryde Music Ministries, Inc. This amendment was filed on February 27, 2002. At that time Mr. Brown also named himself as registered agent and directed all mail to go to him in Tampa. Since then, Mr. Brown and the church severed all ties. The church board knew nothing of these changes until recently.


