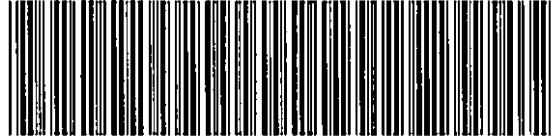

SECOND: The name of the Corporation shall be changed to:


YPO FLORIDA GOLD, INC.
