
**ARTICLES OF DISSOLUTION**


Suncoast Harvest Food Bank, Inc., a Florida not for profit corporation, executes the following articles of dissolution pursuant to Section 617.1403 of the Florida Business Corporation Act:

- FIRST: The name of the corporation is Suncoast Harvest Food Bank, Inc. (the "Corporation").
- SECOND: The company's articles of incorporation were filed on January 24, 1991 under the name of Pasco Food Depot, Inc.
- THIRD: The company changed its name from Pasco Food Depot, Inc. to Suncoast Harvest Food Bank, Inc. on August 27, 2001.
- FOURTH: The Corporation does not have any unpaid debt.
- FIFTH: The board of directors of the Corporation authorized the dissolution of the Corporation at a meeting on November 15, 2011. The number of votes cast by the members was sufficient for approval.
- SIXTH: The resolution was adopted by written consent of the members and executed in accordance with section 617.0701, Florida Statutes.
