Articles of Amendment of The First Baptist Church of Bartow, Florida, Inc.

Pursuant to vote of the membership of The First Baptist Church of Bartow, Florida, Inc. on the 11 day of November, 2009 wherein the number of votes cast for the Amendment to the Article of Incorporation (Corporate Charter) was sufficient for approval, the following Articles of Amendment are submitted for filing pursuant to the laws of the State of Florida:

### ARTICLE V - POLITY

The government of The First Baptist Church of Bartow, Florida, Inc. is vested in the membership of said Church.

The Deacons, church committees, and/or other church groups, created and empowered by the church, shall report to and be accountable only to the church membership, unless otherwise specified by church membership action.

### ARTICLE VI - DIRECTORS

The Directors of this corporation shall be: the Pastor of the church; the Chairman of the Deacons; the Vice Chairman of the Deacons; the Chairman of the Stewardship Committee; and the Chairman of Properties Committee.
