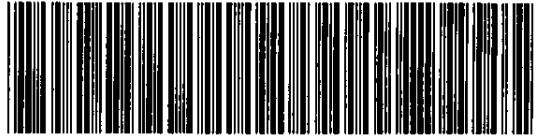

Articles of Amendment  
of  
The First Baptist Church of Bartow, Florida, Inc.

Pursuant to vote of the membership of The First Baptist Church of Bartow, Florida, Inc. on the 11 day of November, 2009 wherein the number of votes cast for the Amendment to the Article of Incorporation (Corporate Charter) was sufficient for approval, the following Articles of Amendment are submitted for filing pursuant to the laws of the State of Florida:

ARTICLE V - POLITY

The government of The First Baptist Church of Bartow, Florida, Inc. is vested in the membership of said Church.

The Deacons, church committees, and/or other church groups, created and empowered by the church, shall report to and be accountable only to the church membership, unless otherwise specified by church membership action.

ARTICLE VI - DIRECTORS

The Directors of this corporation shall be: the Pastor of the church; the Chairman of the Deacons; the Vice Chairman of the Deacons; the Chairman of the Stewardship Committee; and the Chairman of Properties Committee. The Directors shall manage the "business affairs" of this corporation pursuant to the direction and authorization of the Church membership. "Business affairs" is herein defined as secular matters, as distinguished from "religious matters". For example, "business affairs" would include such matters as stated in the second sentence of Article II of the Articles of Incorporation (Corporate Charter).

ARTICLE VII - OFFICERS

The Officers of this corporation shall be: The Chairman of Deacons; the Vice Chairman of Deacons; the Church Clerk; and the Church Treasurer. All legal documents of the corporation shall be executed in the Church's legal name by the Chairman or Vice Chairman, as authorized by the membership of The First Baptist Church of Bartow, Florida, Inc. and in accordance with the laws of the State of Florida.
