ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
GAINESVILLE-OCALA MARINE INSTITUTE NORTH, INC.

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, Gainesville-Ocala Marine Institute North, Inc., adopts the following Articles of Amendment to its Articles of Incorporation.

1. Article I of the Articles of Incorporation is amended to read:

ARTICLE I - NAME

The name of this Corporation shall be Alachua Regional Marine Institute, Inc.

2.
