**ARTICLES OF AMENDMENT TO
THE AMENDED AND RESTATED
ARTICLES OF INCORPORATION OF
ALACHUA REGIONAL MARINE INSTITUTE, INC.**

A. The name of this Corporation is Alachua Regional Marine Institute, Inc.

B. An amendment to Article I of the Amended and Restated Articles of Incorporation of this Corporation were adopted on October 3, 2002 by Associated Marine Institutes, Inc., the sole member of the Corporation, to change the name of the Corporation. As amended, Article I now reads as follows:

ARTICLE I-NAME

The name of this Corporation shall be Gainesville Wilderness Institute, Inc.

There are no other amendments to the Articles of Incorporation, except as stated above.

C. The sole member of this Corporation was entitled to vote on these amendments and the number of votes cast for the amendment was sufficient for approval by the Member.
