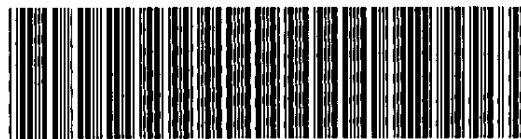

As you are now the sole remaining member of the Board of Directors of the Florida Draft Horse, Pony & Mule Association, we the undersigned, Debra Kriemeyer, Charles (Toby) Pugh, Gary Moe, Jack Dunn, and Don Castagnasso hereby notify you of our resignations, effective this date, as officers and directors, as applicable, of the Florida Draft Horse, Pony & Mule Association, Inc. Debra Kriemeyer resigns as President, Charles (Toby) Pugh resigns as Vice-President, Gary Moe resigns as Director, Don Castagnasso resigns as Director and Jack Dunn resigns as Director. We will continue to be members of the Association.

Certain personalities, currently in the organization, have made our continuing service toward the FDHPMA unpalatable to us.

The Association's bank account is held at SunTrust Bank, 203 E. Silver Springs Blvd., Ocala, Florida 34470. Debra Kriemeyer and Toby Pugh, as former authorized signatures for the bank account, have contacted SunTrust and revoked their signature authorization's from the FDHPMA account. So, upon your receipt of this letter, there are no authorized signatures for the account. Since the address printed on the checks is no longer applicable, the remaining unused checks of this account have been turned over to the bank for destruction.

Debra Kriemeyer has also submitted to the Florida Secretary of State's Office her resignation as the corporation's registered representative. The Association's Annual Report, filed with the Florida Secretary of State's Office should be amended to reflect these resignations as well as the resignation earlier this year of Joanne Forbidussi as the Association's former Secretary/Treasurer.

You should contact Toby Pugh and Carole Tate to make arrangements to pick up the Association's property, files and file cabinet.

As you may know, some of us recently met with an attorney and Certified Public Accountant. We were advised that the Association should file with the Internal Revenue Service, an Application for Recognition of Exemption as a non profit corporation. It is our recommendation to you that this be done.
