

Pursuant to the provisions of Section 617.1006, <u>Florida Statutes</u>, this Florida Not For Profit Corporation adopts the following Amended and Restated Articles of Incorporation, thus amending in their entirety the Articles of Incorporation dated January 10, 1991, and substituting therefor the following:

ARTICLE I NAME

The name of this corporation is EDUCATION FOUNDATION OF MARTIN COUNTY, INC. (hereinafter the "Foundation"). The Foundation was formerly known as Martin County Education Foundation, Inc.

ARTICLE III ENABLING LAW

This Foundation is organized pursuant to the Corporation Not For Profit Act of the State of Florida, set forth in Chapter 617 of the <u>Florida Statutes</u>.

ARTICLE IV PURPOSES

- A. This Foundation is organized exclusively for charitable, scientific and other educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue code of 1986. The powers of the Foundation include transacting any or all lawful business for which corporation may be incorporated under the Florida Not For Profit Corporation Act.
- B. No dividends shall be paid, and no part of the income of the Foundation shall be distributed or inure to the benefit of any member, director or officer.
- C. This Foundation shall have and exercise all rights and powers conferred upon corporations under the laws of the State of Florida, provided, however, that this

Foundation is not empowered to engage in any activity that in itself is not in furtherance of its purposes as set forth in Paragraph A of this Article.

D. Other provisions of these Articles of Incorporation notwithstanding, this Foundation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future Untied States Internal Revenue Law; or (b) a corporation to which contributions are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 or any other corresponding provisions of any future Untied States Internal Revenue Law.

ARTICLE V TERM

This Foundation shall have a perpetual existence.

ARTICLE VI INCORPORATORS

ARTICLE VII BOARD OF DIRECTORS

The manner in which the directors are elected or appointed shall be provided for in the Bylaws of this Foundation.

ARTICLE VIII REGISTERED AGENT

The address of this Foundation's registered office in the State of Florida and the agent at said address is: LISA RHODES, 500 EAST OCEAN BOULEVARD, STUART, FL 34994. Changes to the registered office and registered agent may be made by changes on the Foundation's annual report filed with the Department of State or otherwise as provided by Florida law without the necessity of amending the Foundation's Articles of Incorporation.

ARTICLE IX AMENDMENTS

These Articles of Incorporation may be amended by a majority vote of the members of the Foundation's Board of Directors at any regular annual meeting or at any special meeting called for that purpose. Any such amendment shall be effective upon the filing thereof with the Department of State of the State of Florida.

ARTICLE X DISSOLUTION

In the event of dissolution of this Foundation, property of the Foundation shall be distributed in such shares as the Board of Directors may in their sole discretion then determine to one or more organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code, or the corresponding provisions of any subsequent federal tax laws, or to the Federal, State or Local government for exclusive public use. Any such property not disposed of shall be disposed of by the Nineteenth Judicial Circuit Court, in and for Martin County, Florida, as said Court shall determine, to any or more organizations described herein.

The undersigned President of the Foundation hereby certifies that the above Amended Articles of Incorporation (i) were adopted on <u>Sept. 12</u>, 2011, by a 2/3 vote of the Board of Directors at a special meeting, (ii) were approved by the School Board of Martin County, Florida, on <u>Nov. 15</u>, 2011, and (iii) that no members of the Foundation were otherwise entitled to vote thereon.
