1. That Article IV, Section 2 is hereby amended to read as follows:

ARTICLE VI Board of Directors

<u>Section 2</u>. There shall be three classes of directors, to be known as Class A, Class B, and Class C, respectively. The names and addresses of the members of the Board of Directors who shall hold office until their successors are elected and have qualified, or until their death, resignation, or removal, are as follows:

The term of office for each Class of directors shall be three (3) years. The terms of the directors shall be staggered. The term of office of the Class A directors shall expire upon the election and qualification of their successors at the December 1998 annual meeting of the members; the term of the Class B directors shall expire upon the election and qualification of their successors at the December 1999 annual meeting of members; and the term of the Class C directors shall expire upon the election and qualification of their successors at the December 2000 annual meeting of members. Upon expiration of the terms of office of the directors are as classified above, their successors shall be elected for the term of three (3) years each. In case of any increase in the number of directors, the additional directorships so created shall serve for an initial term of three years. A director shall not be entitled to be reelected to serve are as a director if such reelection for a three (3) year term would result in such director serving for more than twelve (12) consecutive years (inclusive of the time served by such director are as an initial director named above); provided, however, a former director who is ineligible for reelection by reason of this limitation may be subsequently reelected to serve are as a director provided such person has not been a director for at least one year preceding his reelection. The Annual Meeting is now held in December of each year.

- 2. The members of the corporation were not entitled to vote on this Amendment to the Articles of Incorporation.
- 3. The foregoing amendments were unanimously adopted by the directors of the corporation on December <u>1</u>, 1998.
- 4. The effective date of the foregoing amendment is December <u>1</u>, 1998, or if filed later, when filed with the Secretary of State.
