
Articles of Dissolution

Pursuant to section 617.1402 -1403 of the Florida Statutes, **Palm Lakes Property Owners Association, Inc.** (the "Corporation") submits the following articles of dissolution:

1. The name of the Corporation is **Palm Lakes Property Owners Association, Inc.**; and
2. The Corporation has three members who are entitled to vote on the dissolution of the Corporation. The members, by unanimous consent to action dated April 21, 2015, approved the dissolution of the Corporation. The number of votes cast for dissolution as sufficient for approval; and
3. The effective date of dissolution is June 30<sup>th</sup>, 2015; and
4. That all liabilities and obligations of the Corporation have been paid or discharged or that adequate provision has been made therefore; and
5. That there are no remaining assets or property of the Corporation; and
6. That there are no actions pending against the Corporation in any court or that adequate provision has been made for the satisfaction of any judgment, order or decree which may be entered against it in any pending action.
