ARTICLES OF INCORPORATION OF

A FLORIDA CORPORATION NOT-FOR-PROFIT

Pursuant to Section 617.1006, Florida Statutes, the President of **REDEMPTIVE LIFE MINISTRIES, INC.**, a Florida corporation not-for-profit (the "Corporation"), a corporation organized and existing under the Florida Not-For-Profit Corporation Act, does hereby certify as follows:

1. Article I of the Articles of Incorporation, after the amendment, shall be as set forth below:

ARTICLE I
NAME
