## N42498 Amendment for Article 11 & Article 1X Addendum

Article 1X. continued.

Any such assets not disp used of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

No part of the net car sings of the organization shall inure to the benefit of, or be distributable to its nembers, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in further ance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be carrying on of propaganda, or other vise attempting to influence legislation, and the organization shall not participate ir, or intervene in (including the publishing or distribution of statements) any politi al campaign on behalf of any candidate for public office. Notwithstanding any other activities not permitted to be carried on (a) by an organization except from federal is come tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Cod :, or corresponding section of any future federal tax code.
