ARTICLES OF MERGER



AGREEMENT AND PLAN OF MERGER

Now on this 27th day of May, 2003, **CHRISTIAN FELLOWSHIP ALIVE MINISTRIES, INC. and CHURCH OF THE REDEEMER OF ST. LUCIE COUNTY**, both Florida Non-Profit Corporations, pursuant to the Business Corporation Act of the State of Florida, have entered into the following Agreement of Merger;

WITNESSETH that:

WHEREAS, the respective Board of Directors of the foregoing named corporations deem it advisable that the corporations merge into a single corporation as hereinafter specified; and

WHEREAS, said CHRISTIAN FELLOWSHIP ALIVE MINISTRIES, INC., duly organized and in good standing with the office of the Secretary of State of the State of Florida;

WHEREAS, said CHURCH OF THE REDEEMER OF ST. LUCIE COUNTY, INC., duly organized and in good standing with the office of the Secretary of State of Florida;

NOW, THEREFORE, the corporations, parties to this Agreement, by and between their respective Board of Directors, in consideration of the mutual covenants, agreements, and provisions hereinafter contained, do hereby prescribe the terms and conditions of said merger and of carrying the same into effect as follows:

FIRST: CHRISTIAN FELLOWSHIP ALIVE MINISTRIES, INC. hereby merges into itself CHURCH OF THE REDEEMER OF ST. LUCIE COUNTY, INC. and said CHURCH OF THE REDEEMER OF ST. LUCIE COUNTY, INC. shall be and hereby is merged into CHRISTIAN FELLOWSHIP ALIVE MINISTRIES, INC. which shall be the surviving corporation.

SECOND: The Articles of Incorporation of CHRISTIAN FELLOWSHIP ALIVE MINISTRIES, INC. as in effect on the date of the merger provided for in this Agreement, shall continue in full force and effect as the Articles of Incorporation of the corporation surviving this merger.

THIRD: That CHRISTIAN FELLOWSHIP ALIVE MINISTRIES, INC., a Florida corporation, will assume all obligations of CHURCH OF THE REDEEMER OF ST. LUCIE COUNTY, INC., including that certain mortgage dated September 13, 2002, in favor of Billy Ray Mathis and Patricia A. Mathis, husband and wife, and recorded in Official Records Book 1580, page 2804, of the public records of St. Lucie County, Florida.

FOURTH: This merger shall become effective upon filing with the Secretary of State of Florida.

IN WITNESS WHEREOF, the parties to this Agreement, pursuant to authority duly given by their respective Board of Directors, have caused these presents to be executed by the President (or Vice-President) and attested by the Secretary (or Assistant Secretary) of each party hereto.


