#### Articles of Amendment

## To The Articles of Incorporation

of

# BAPTIST HEALTH SYSTEMS OF SOUTH FLORIDA, INC. (a Not For Profit Corporation)

By majority vote of the Board of Trustees and the Members of Baptist Health Systems of South Florida, Inc., at a meeting held on March 25, 2002, at which a quorum was present, the Board of Trustees and the Members adopted the following amendments to the Articles of Incorporation with such amendments to be effective as of March 25, 2002:

- The name of the Corporation in the heading of the Articles of Incorporation is changed from "BAPTIST HEALTH SYSTEMS OF SOUTH FLORIDA, INC." to "BAPTIST HEALTH SOUTH FLORIDA, INC."
  - 2. Article I is amended to read as follows:

#### ARTICLE I - NAME AND ADDRESS

The name of the Corporation shall be BAPTIST HEALTH SOUTH FLORIDA, INC., and it shall be located at 6855 Red Road, Coral Gables, Florida 33143.

These Articles of Amendment were duly adopted by the Board of Trustees of Baptist Health Systems of South Florida, Inc. on March 25, 2002. The members of the Board of Trustees of Baptist Health Systems of South Florida, Inc. are the Members of Baptist Health Systems of South Florida, Inc. and the number of votes cast by the Members and the Trustees for the Amendments was sufficient for approval. The Amendments included in the Amended and Restated Articles of Incorporation have been adopted pursuant to Sections 617.1002 and 617.1006, Florida Statutes and there is no discrepancy between the Articles of Incorporation as previously filed and amended and the provisions of these Amended and Restated Articles of Incorporation other than the inclusion of the Amendments adopted pursuant to Sections 617.1002 and 617.1006, Florida Statutes.
