Elders and Deacons (1 Timothy. 3, Tit. 1:5-9) are to be raised up within the local assembly. Elders and Deacons are under the supervision of the Five Fold Ministry listed in Ephesians 4:11 (Acts 15, 1 Timothy 5:17-21, Titus 1:5-9)
- 31. Page 9. Article VI. Membership. First line, Name change to Freedom House Fellowship, Inc.

  - Page 9. Article VII. "Board of trustees" replaces" "Designation of responsibilities" This is the new wording for all of Article VII. Section 1. The Elders shall serve as Trustees of the church and as advisors to the Pastors of the church.
  - The Pastors of the church shall be President and Vice President of the Trustees and shall serve as the recognized overseers of all the church affairs. Section 2.

<u>Elders</u>. When the Pastors deem that the church has people who are recognized by the congregation as mature leaders, a selected number of them shall be chosen as local Elders to help the Pastors oversee the spiritual and legal affairs of the church. These people shall be chosen from among the members of the church. The choosing and ordaining of Elders is the responsibility solely of the Holy Spirit and the Pastors of the church. The local Elders shall not usurp the place of the Pastors, but shall serve with them and under their supervision in the oversight of the church. These local Elders shall also serve as the Board of Trustees. Deacons shall be nominated and appointed to aid the Pastors and Elders in their work in the congregation.

Elders and Deacons serve for a three-year term. At the completion of their three-year term the Elder or Deacon will step down for at least a twelve-month (one year) rest.

After a one year rest, he/she is eligible to again be appointed to a leadership position. In some cases, of special circumstances a Deacon or Elder may request a second consecutive

three year term without a year of rest. This exemption is subject to approval of the Board of Trustees.

<u>Section 3</u>. The affairs of the church shall be managed by its Senior Pastors which may exercise all such powers of the church and do all such lawful acts and things as are not by statute or by the Articles of Incorporation or by these By-laws directed or required to be exercised or done by the voting members.

Section 4. The Trustees may keep the books of the church, except such as required by law to be kept within the state, outside of the State of Florida at such place or places as they may from time to time determine.

Section 5. A majority of the Trustees shall constitute a quorum for the transaction of business unless a greater number is required by law or by the Articles of Incorporation. The action of the Board of Trustees must be done when a majority of the Trustees is present at any meeting, unless the action of a greater number is required by statutes or by the Articles of Incorporation. If a quorum shall not be present at any meeting of the Trustees, those present at such meeting may adjourn the meeting without notice, other than to make an announcement at the meeting, until a quorum shall be present.

Section 6. Any action required or permitted to be taken at a meeting of the Trustees may be

- taken without a meeting if a consent in writing, setting forth the actions taken, shall be signed by all of the Trustees entitled to vote with respect to the subject matter thereof.
