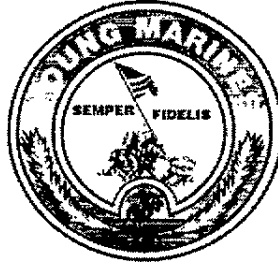


I need your help. I am filing for a 501 ( c ) 3 tax exemption, I filled out form 1023 and I received the attached letter from the IRS.

## **Amendment to Articles of Incorporation**

### **Young Marines of Dade, M.C.L., Inc.**

The undersigned acting as incorporator(s) of a corporation benefiting minors pursuant to Chapter 617, Florida Statutes, adopt(s) the following Amendments to the Articles of Incorporation:

#### **Article I**

The name of the corporation is: Young Marines of Dade, MCL, Inc. and the initial principal address of the corporation is: 13420 SW. 79<sup>th</sup>. Street, Miami, Florida 33183-4104.

#### **Article II**

The period of duration of this corporation is perpetual unless dissolved according to law. Corporate existence shall commence upon filing with the Secretary of State.

#### **Article III**

The purpose or purposes for which the corporation is organized are: The Young Marine Program, a youth educational co-ed program, educates and inspires the youth, ages 8-18, within our communities by promoting a healthy and drug-free lifestyle through instructional responsible citizens using the volunteer resources of a civilian and military partnership. The teamwork and Espirit-de-corps enjoyed by the Young Marines help them to discover the hero within.

#### **Article IV**

The qualifications for members, adult volunteers and the manner of their admission are: The young Marines program is open to all boys and girls ages 8-18 years old with parental permission and approval.

The adult volunteers must be at least 18 years of age and older, and must have already graduated from High School. Have no felony convictions. If served in the U.S. Arm Forces, must provide a copy of a DD214, and if discharged from the military the discharge must be under honorable conditions. Cannot be a member of an organization listed as subversive by the United States Attorney General's office. Have not been adjudged insane. Have not been convicted of child abuse or similar offense(s).

In addition, the volunteer must qualify by submitting an adult volunteer application which goes through a background check at the local and national level of the organization.

#### **Article V**

The street address and city of the initial registered office of the corporation is One Southeast Third Avenue, 1440 Amerifirst building, Miami, Florida 33131. The name of the initial registered agent at such address is Mr. Mark Gallegos, Esq.
