

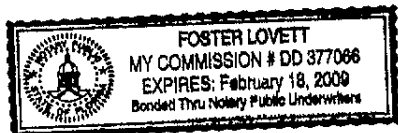
The Articles of Incorporation shall include and be amended as follows :

1. Provide burial expenses and render other benefits to the members of this association.

3. Establish a home ownership program to assist prospective home buyers in becoming knowledgeable homeowners.
4. Conduct pre- and post- home ownership workshops and seminars concerning the responsibility of maintaining a home such as credit counseling, foreclosure prevention and home maintenance.
5. Purchase vacant land, existing homes, construct infill homes and rehab existing homes for the benefit of low and moderate income individuals and families.
6. Establish an economic and investment program that will benefit the above individuals.
7. Establish and maintain an apprentice and training program in the fields of residential and commercial construction and home maintenance.
8. Collaborate with other non-profits and for-profit organizations in various joint ventures that assist low and moderate income individuals and families.
9. To make charitable donations to various non-profit organizations that are established to assist low and moderate income individuals and families.
10. Transact any and all lawful business that will benefit this association and its members.
