


The Articles of Incorporation shall include and be amended as follows:

- 1. Provide burial expenses and render other benefits to the members of this association.
- 2. Provide funds to establish decent ,sanitary and safe affordable housing for low and moderate income individuals and families .
- 3. Establish a home ownership program to assist prospective home buyers in becoming knowledgeable homeowners.
- 4. Conduct pre- and post- home ownership workshops and seminars concerning the responsibility of maintaining a home such as credit counseling, foreclosure prevention and home maintenance.
- 5. Purchase vacant land, existing homes, construct infill homes and rehab existing homes for the benefit of low and moderate income individuals and families.
- 6. Establish an economic and investment program that will benefit the above individuals.
- 7. Establish and maintain an apprentice and training program in the fields of residential and commercial construction and home maintenance.
- 8. Collaborate with other non-profits and for-profit organizations in various joint ventures that assist low and moderate income individuals and families.
- 9. To make charitable donations to various non-profit organizations that are established to assist low and moderate income individuals and families.
- 10. Transact any and all lawful business that will benefit this association and its members.
