The affairs of the Association will be managed by a Board of Administration initially consisting of three directors who need not be members of the Association. Thereafter, the Board shall consist of the number of Directors as set forth in the By-Laws.

At such time as the members are entitled to elect all Directors as set forth in F.S. 718.301, and subject to the provisions of the By Laws, the Boards shall consist of one (1) Director elected from each of the buildings in this condominium so that the number of directors shall equal the number of buildings in this condominium.

Directors of the Association shall be elected at the annual meeting in the manner provided by the By-Laws. Directors may be removed and vacancies on the Board shall be filled in the manner provided by the By-Laws.
