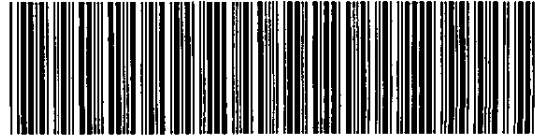



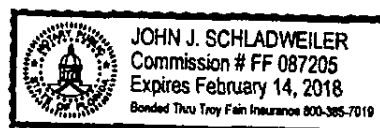

OF REGENCY COVE, INC. AND TO THE REGENCY COVE, A COOPERATIVE
MASTER OCCUPANCY AGREEMENT**

Articles of Incorporation

Adopted amendment to ARTICLE SIX of the Articles of Incorporation of Homes of Regency Cove, Inc., to read as follows:

ARTICLE SIX – VOTING MEMBERSHIPS

The maximum number of voting memberships shall be equal to the number of lots in the Park; at the present time there are 436 427 lots. All Memberships shall have equal voting rights.
