Amendments to Section 1 and 2.1 of the Articles of Incorporation to provide as follows:

- 1. NAME. The name of this corporation shall be VILLA TOSCANA AT CORAL GABLES CONDOMINIUM—ASSOCIATION, INC. ("Association").
